Notifications and Sections 2(d), 5 and 6 of the Act, and am fully aware of the penal  
and administrative action that is liable to be taken against my ward in case he/she  
is found guilty of or abetting ragging actively or passively, or being part of a  
conspiracy to promote ragging.

4. I hereby, solemnly aver and undertake that :
  - a) My ward will not indulge in any behavior or act that may be constituted as ragging under various clauses of AICTE notification, Regulations and Sections 2(d) of the Act.
  - b) My ward will not participate in or abet or propagate through an act of commission or omission that may be constituted as ragging under various 4 of AICTE notification, the Regulations and section 2(d) of the Act.

I hereby affirm that, if found guilty of ragging, my ward is liable for punishment in accordance with various clauses of AICTE notifications, regulations and sections 5 and 6 of the Act, without prejudice to any other criminal action that may be taken against my ward under any penal law or any lpaw for the time being in force.
